This FROZEN SEMEN ADDENDUM agreement ("Agreement") is entered into ("Effective Date") as identified by date and signature on Page 3 of the breeding contract, and as signed below for breeding services by and between the stallion owner ("Stallion Owner"-HBF CMI-Chase Farms, or DGS-DeGraff Stables, Inc.;

Shipping Terms and Conditions. Mare owner is entitled to receive up to 2 doses of frozen semen for use in the breeding year, with allowance for one additional dose of semen, and will be reserved for use upon notification and verification of need.

Frozen semen will only be shipped to the address of a veterinarian approved by Stallion Owner or its storage agent. The parties agree that the obligations of performance by the shipping agent and by Stallion Owner shall be met when the frozen semen shipment is tendered to parcel delivery service for shipment and risk of loss transfers to Mare Owner.

Mare Owner must arrange for a liquid nitrogen storage tank and transfer the frozen semen from the Dry Shipper to the liquid nitrogen storage tank immediately upon arrival. The Mare Owner should inspect the Dry Shipper and ensure that the zip tie is intact on the latch and that the inside of the Dry Shipper is frosted when opened to transfer the semen.

Waiver of Liability. Mare Owner agrees to diligently try to settle The Mare(s). If any of The Mare(s) do/does not settle, Mare Owner will hold Stallion Owner harmless from any loss or damage.

Stallion Owner retains ownership rights to any unused doses/straws of semen and reserves the right to reclaim those doses at no cost to Mare Owner. Unused doses of frozen semen may not be used in any other year or on any other uncontracted mare without advance approval in writing from Stallion Owner.

Certificate and Multiple Foals. Upon notification of birth of a live foal and full payment of all fees and expenses and the performance of all other obligations of Mare Owner under this Agreement, Breeder's reports will be submitted and Breeder's Certificates will be issued by Stallion Owner and mailed to Mare Owner for each of The Mares which immediately following the live birth of foal, providing that a) Mare Owner's veterinarian provides (by mail, fax, or email) completed and signed insemination certificates for each insemination complete with number of doses of semen used, and b) all accounts are fully paid to stallion owner and agent.

The LFG will become void if the following conditions are not met: a. Mare Owner must forward a certification signed by the breeding vet that Mare did not settle and is not in foal by the end of breeding season; or, Mare Owner must notify Stallion Owner within forty-eight (48) hours of foaling or aborting that the mare did not produce a live foal; and within fourteen (14) days after Mare Owner's notice to Stallion Owner, the Mare Owner certifies to Stallion Owner that the birth was properly attended, and also provides proof of proper administration of rhinopneumonitis vaccine in the 5th, 7th, and 9th months of gestation, and also produces a statement from Mare Owner's licensed veterinarian stating details explaining the failure of the mare to produce a live foal.

WARRANTY. NO WARRANTIES WHATSOEVER, EXPRESS OR IMPLIED, SHALL ACCOMPANY A BREEDING COVERED BY THIS AGREEMENT. NO GUARANTEE OF DELIVERY OF SHIPPED FROZEN SEMEN WITHIN A CERTAIN TIME PERIOD OR GUARANTEE THAT SHIPPED FROZEN SEMEN WILL SAFELY REACH THE INSEMINATION POINT OR WILL BE THAWED WITHOUT LOSING SOME OF ITS INTEGRITY, QUALITY OR CHARACTERISTICS WILL BE GIVEN.
